As part of the judicial liquidation procedure of SAS CADDIE, ZA d'Eigen rue du Canal 67490 DETTWILLER, the sale of intangible assets is implemented.

Below you will find the information necessary to familiarise yourself with the file and, if necessary, to submit an offer.

## **1. PROCEDURE**

By judgment dated 28 May 2024, the Saverne Judicial Court opened a "redressement judiciaire" proceedings against SAS CADDIE, ZA d'Eigen rue du Canal 67490 DETTWILLER and appointed:

- Mr Jean DIEBOLT in his capacity as supervisory judge,
- SELARL ADJE, in the person of Christophe GILLME, as director,
- SELARL MJ SYNERGIE, in the person of Maître Nicolas FLESCH, as judicial representative.

In the absence of a satisfactory takeover offer, the court, by judgment dated June 27, 2024, converted the procedure into judicial liquidation, terminated the functions of the judicial administrator and appointed SELARL MJ SYNERGIE, in the person of Mr. Nicolas FLESCH, as liquidator.

As part of this procedure, the sale of the assets held by CADDIE is envisaged.

This call for tenders, the scope of which is detailed below, concerns the company's intangible assets.

## **2. SCOPE OF THE CALL FOR TENDERS**

This call for tenders concerns the trademarks and domain names held by the company CADDIE.

It is brought to the attention of potential bidders that some of these trademarks are still registered with the INPI as belonging to the former company CADDIE, the company LES ATELIERS REUNIS CADDIE or the company ALTIA INDUSTRY, all former operators of the fund.

The necessary steps to draw up the deeds of transfer of the trademarks in favour of SAS CADDIE, the real owner of the trademarks, will be carried out by the undersigned.

CADDIE has granted two licensing agreements for the use of its trademark portfolio.

These contracts may be communicated by the undersigned to the prospective purchasers upon request on their part and upon submission of a confidentiality undertaking.

## **3. ADDITIONAL INFORMATION**

The liquidator will take all necessary measures to preserve and preserve the rights relating to the trademarks and domain names in the context of the liquidation proceedings.

Once the authorisation of the *juge-commissaire* has been obtained and the deeds of transfer have been signed, the liquidator will no longer be held liable for the payment of the costs relating to this conservation and preservation.

All the costs necessary for the renewal of the rights will be borne by the buyer.

**No information relating to the valuation of the brands will be sent to the candidates.**

Tenders must present sufficient financial guarantees, which must be explicitly presented in the content of the tender.

#### **4. PROCEDURE INFORMATION**

Tenders must be sent to the Registry of the Judicial Court of SAVERNE with a copy to the undersigned before the expiry of the deadline for submission of tenders.

**The portfolios are indivisible and interdependent so that they will be transferred in a single batch (trademarks + domain names).**

The offer must be written in French.

At the end of the deadline for submitting tenders, the undersigned may analyse the content of each tender and, if necessary, request additional information.

A request will then be filed with the supervisory judge in order to summon the candidates whose offer is likely to be accepted, in order to hear them on their offer.

At this hearing, each candidate will have to present himself with a cashier's check for the amount of his offer.

In any event, candidates are told that the transfer is necessarily subject to the agreement of the *juge-commissaire*.

The deeds of transfer must be drawn up by the buyer and all costs arising from the drafting and registration of these deeds will be borne by the buyer.

## 5. PRESENTATION OF THE BUYER

In order to be effectively studied and considered admissible, the tender must indicate:

- 1) The candidate's contact details (legal form, company name, head office, etc.) supported by:
  - Extract kbis of the company less than 3 months old,
  - Statutes
  - Up-to-date list of partners/shareholders, with distribution of share capital,
  - Copy of a valid identity document for the director and any partner with more than 25% of the voting rights or capital,
- 2) Sale price it being specified that this price **is exclusive of registration duty**.
- 3) Certificate of financing,
- 4) Proof of the origin of the funds allowing you to acquire the wallets, it being specified that the funds must transit through a French bank, or a member country of the European Union or the European Economic Area.
- 5) Presentation of the economic project in which the acquisition of the portfolios is a part.

Only a complete file containing all the above-mentioned documents may be submitted to the assessment of the *juge-commissaire*.
